WHAT YOU NEED TO KNOW:

Rule 1.14(a) of the Rules of the Supreme Court of the State of Hawaii ("RSCH") requires that each person licensed to practice law after July 1, 2001, shall, no later than December 31 of the year following the year of election of active status, complete the Hawai'i Professionalism Course conducted under the joint sponsorship of the Hawai'i State Bar Association ("HSBA") and the Supreme Court of Hawai'i.

Failure to complete this course within the time period specified shall result in automatic suspension of the license to practice law. The mandatory Hawaii Professionalism Course is administered only twice a year, in June and November on the island of Oahu. In-person attendance is required.

Please familiarize yourself with RSCH 1.14, RSCH 22, and RSCH 17.
