## State and Federal Legislative Updates and Developments

In this program, you will hear from a panel of distinguished speakers about recent state and federal law developments. Ryan Sanada, Esq., Hawaii Employers Council, will provide a review of the 2017 Hawaii legislative employment law initiatives, including paid sick leave, social media privacy, expansion of the Hawaii Family Leave Law, changes to the definition of independent contractors, increased penalties for failure to comply with Hawaii employment laws, and revisions to Hawaii's workers' compensation system. Robin Wurtzel, Esq., Hawaii Civil Rights Commission will share her insights and perspectives on civil rights related Hawaii legislative initiatives. And John Knorek, Esq., Torkildson, Katz, Moore, Hetherington & Harris, will cover the recent developments at federal employment agencies and the possible impact the Trump budget proposal may have on these agencies. You will learn what is happening at the NLRB, DOL, EEOC, and OFCCP and how Federal Appellate Courts as well as the Supreme Court may rule on pending employment and labor law cases.
