The Supreme Court's recently-concluded Term already seems clearly to be one for the ages. This is not only because its final decisions included rejection of Roe v. Wade and Roe's "progeny," as well as the extension of Second Amendment rights. The Term also was pathbreaking in a majority's application of well-established rules and customs regarding the Court's emergency powers and its "shadow docket." It further featured key administrative law rulings and a new majority's philosophy of the institutional role of the Court.


