LRIS RULES FOR ATTORNEY MEMBERSHIP

Competency & Membership Requirements

1. All Lawyer Referral & Information Service (hereinafter “LRIS”) attorney members must be duly licensed to practice in the State of Hawaii and abide by the Hawaii Rules of Professional Conduct promulgated by the Hawaii State Supreme Court.
2. All LRIS attorneys must maintain an active HSBA membership and a full-time law office in Hawaii.
3. Because the LRIS is a public service, each member is expected to assist a referral to the fullest extent possible. If a referral does not need legal advice, the LRIS member shall forward the referral to an appropriate agency or suggest other means such as mediation or small claims court self-representation.
4. A LRIS Member shall provide competent representation to a client. Competent representation requires the legal knowledge, skill, thoroughness, and preparation reasonably necessary for the representation. [Hawaii Rules of Professional Conduct Rule 1.1]
5. If an LRIS member or firm receiving a referral is not able to accept representation of the matter, the LRIS Member shall refer the case back to the LRIS.
6. All LRIS members shall carry a minimum of \$100,000 in professional liability insurance coverage and will furnish their insurance carrier name, policy number and dates of effective coverage to the LRIS office annually.
7. Any determination by the Hawaii Supreme Court, that an attorney has violated the Hawaii Rules of Professional Conduct, resulting in suspension or disbarment, shall result in the automatic removal of the attorney from the LRIS.
8. Each LRIS member shall immediately notify the LRIS: if he/or she becomes ineligible or disqualified, temporarily or permanently, to accept referrals from the Service.

Application & Client Relation

9. A LRIS member must complete an application form designating only those areas in which they are qualified to practice.
10. An LRIS member may withdraw their name from the program at any time by written notice to the LRIS.
11. All LRIS members will notify the LRIS and the Hawaii State Bar Association within 30 days of any change of license registration information [RSCH 17(d)(1)].
12. Representation undertaken thru referrals are the sole responsibility of the LRIS member.
13. Any disputes arising over fees as a result of employment gained through participation in LRIS shall be subject to binding arbitration by the Hawaii State Bar Association’s Attorney/Client Relations Committee.
14. Non-payment of dues after 30 days from the annual billing date (July 1) will result in termination of membership in the LRIS.
15. Under no circumstances shall an LRIS member hold the Hawaii State Bar Association, staff, Board, or committee member liable for any acts or omissions in connection with the LRIS.
16. These rules are subject to change at any time without notice by the LRIS Committee as approved by the Hawaii State Bar Association Board. Failure to comply with any of the duties set forth herein will result in removal from the LRIS.
