What is the HSBA Bar Card and what is it used for?

The Bar Card is a photo ID to show proof of HSBA membership. The bar card gives attorneys access to private and secured areas like judges' chambers. Only attorneys with photos on their cards will be allowed to use it for courthouse identification. The bar card may be used at the Supreme Court Law library to borrow books. The bar card will show proof of membership to receive discounts from numerous benefit providers.
