The Young Lawyers Division of the Hawaii State Bar Association is pleased to announce the planning and preparation for the 2022 Hawaii High School Mock Trial Competition.

Similar to last year, this year's Competition will be conducted virtually. While we had hoped that the remote format of the competition would be only for one year, the Committee has determined that the safety of our students, coaches, parents, volunteers and our dedicated Judges must take priority. Regardless of the format, we know that you and your students will put on amazing performances, and gain disciplined organization skills and improve their confidence in their oratory talents. Our targeted start date for the ACTUAL competition is in mid-February of 2022.

The 2022 Mock Trial Competition will involve a **civil** case. The case materials, along with the Competition rules and other related documents, will be posted on the HSBA's website (https://hsba.org/mocktrial2021) by November 5, 2021.

All Hawaii high schools are invited to participate. If your school is interested in organizing a mock trial team, please submit a completed application form (attached), along with the non-refundable \$250 entry fee, by Friday, November 12, 2021. Teams must have at least seven (7) student participants and a coach. If your school would like assistance securing an attorney coach, please contact us.

In closing, the 2022 Hawaii High School Mock Trial State Champion will advance to the National Mock Trial Championship. Please be advised that the 2022 National Championship is scheduled for May 5-7, 2022 in Kalamazoo, MI.
